Misleading and deceptive representations by the Australian Government made in trade and commerce about NBN Co. Limited

Dear Mr. Sims,

I am writing to draw the Australian Competition and Consumer Commission's attention to conduct by the Australian Government, through its ministers, that in my submission constitutes a direct contravention of section 18 of Schedule 2 of the *Competition and Consumer Act 2010* ('the CCA'), which contains a broad prohibition against misleading or deceptive conduct.

The conduct consists of misleading and deceptive statements made by Ministers, including the Prime Minister, and made in promotional material about NBN Co. published and distributed by the Australian Government on behalf of Ministers.

These statements include variations of the flagrant falsehood that "connection to the NBN is free". This claim is made by the Prime Minister, Ms Gillard, on her official Facebook page. Similar claims have been made by a number of other Ministers including the Minister for Broadband, Communications and the Digital Economy, Senator Conroy; the Minister for Families, Community Services and Indigenous Affairs, Ms. Macklin; and the Minister for School Education, Early Childhood and Youth, Mr. Garrett.

Connection to the NBN is not free. To be connected – and indeed to be able to physically attach a device to the NBN, given NBN Co's publicly articulated construction strategies of 'build-drop' and 'demand-drop' (as explained in the Annex) – a consumer must enter into an agreement with a Retail Service Provider for the latter to provide service. This, without exception, entails financial commitments that typically include initial fees and/or monthly service charges incurred over a contractually specified period.

In particular I draw your attention to the brochure printed and authorized under her electoral communications allowance by Ms. Macklin, which includes this claim: "The NBN will deliver superfast, affordable and reliable broadband internet to every home with a <u>free connection</u>."

This assertion, not even qualified by any caveat that such a connection must be a 'standard connection', is demonstrably false. Even setting aside the reality that a consumer must enter into a contract for active service with an RSP to obtain "superfast, affordable and reliable broadband internet," the NBN Co has made it clear that where provision of a fibre connection to a residential or commercial premises is 'non-standard' (i.e. the required fibre run from the nearest road exceeds a specified distance or involves other abnormal costs) a charge will be levied to defray the expense of such work.

Details of additional misleading and deceptive statements in material about NBN Co. published and distributed on behalf of Ministers are set out in the enclosed Annex.

It is well accepted that the Australian Government is bound by the provisions of the CCA insofar as it is carrying on a business. NBN Co is a government business enterprise involved in trade and commerce. It is wholly owned by the Australian Government, with the Finance and Communications ministers nominated as its Shareholder Ministers.

If NBN Co or one of its officers were to assert that "connection to the NBN is free" this claim would indisputably be subject to section 18 and, in my submission, amount to a contravention of the CCA.

The question that arises is whether exactly the same misleading and deceptive statement made by the Australian Government through its Ministers (including the Prime Minister and one of the two Shareholder Ministers) likewise constitutes a contravention. Surely such a representation is no less a contravention of the CCA if made by the corporation's sole owner in material that makes express reference to the NBN Co, provides extensive information about the NBN Co's business offerings, refers consumers to the NBN Co website for further information, and is unquestionably intended to promote the business of the NBN?

The Government in my opinion, through its ministers, has contravened section 18. We request that the Commission take appropriate action including requiring correction of the misleading statements and an undertaking that they will not be repeated.

ANNEX - Letter of 20 May 2013 - Misleading and deceptive representations by the Australian Government about the trade and commerce of NBN Co. Limited

#### 1. Misleading and deceptive statements

The enclosed material includes a number of variations to the effect that "connection to the NBN is free". Connection is not free. As stated in the letter it requires a contractual commitment to pay an RSP over a specified period of time. If a fibre connection is non-standard (or a premise is outside the fibre footprint) upfront connection charges will also be incurred.

The material claims the NBN "supports high definition video conferencing for e-health and education". This claim misleads consumers by intimating high definition video conferencing is a requirement to obtain health or education services over the network. This is not the case.

The material claims the proposed Coalition version of the NBN "does not" [support -health and education]. While this claim is not directly about the NBN, it is a falsehood clearly intended to promote it as a business by misrepresenting an alternative offering.

The material falsely claims it will cost "up to \$5000 to be connected" to the proposed Coalition version of the NBN which will offer "download speeds of 25 megabits per second". While these two claims are not directly about the NBN, they are false, and are clearly intended to promote it as a business by misrepresenting an alternative offering.


#### 2. 'Demand drop" and 'build drop'

The NBN Co pursued a deployment strategy of 'demand-drop' until mid-2012. Under this approach, fibre was run to street-side pits or poles. The final fibre run from the pit or pole to the interior of each premises would not be installed until an order for active service was received via a Retail Service Provider. Therefore, premises were not actually provided with the NBN (and could not physically connect any device to the NBN) unless a contract for service was in place.

In mid-2012 the deployment strategy was amended to 'build-drop'. Under this approach, fibre is run to enclosures ('PCDs') on the exterior of each premise. Upon receipt of an order for service from an RSP, NBN Co brings the fibre from the PCD through the wall and inside the premise where it is terminated at an Optical Network Termination device. The ONT provides ports for Ethernet and telephone cables.






