- (B) DISOBEY THE ORDER BY DOING AN ACT WHICH THE ORDER REQUIRES YOU TO ABSTAIN FROM DOING;

YOU WILL BE LIABLE TO IMPRISONMENT, SEQUESTRATION OF PROPERTY, OR ANY OTHER ACTION THE COURT MAY DETERMINE.

IF ANY PERSON WHO KNOWS OF THIS ORDER DOES ANYTHING TO ASSIST YOU IN DISOBEYING THE ORDER AS SPECIFIED ABOVE, THEY WILL ALSO BE LIABLE TO IMPRISONMENT, SEQUESTRATION OF PROPERTY, OR ANY OTHER ACTION THE COURT MAY DETERMINE.

#### THE COURT ORDERS THAT:

- 1. Pursuant to r 1.34 of the Federal Court Rules 2011 any requirement that the plaintiff file a supporting affidavit contemporaneously with the originating process be dispensed with.
- 2. Pursuant to r 10.23 of the *Federal Court Rules 2011* the second defendant be deemed to have been served on 7 March 2013 with the originating process and the interlocutory process.
- 3. Until further order the second defendant, John William Ullmann ("Ullmann") be restrained from:
  - 3.1. carrying on a business in Australia by which he or his servants or agents:
    - 3.1.1. provide advice in relation to any financial product (including but not limited to securities);
    - 3.1.2. deal in, or arrange for any person to apply for, or to acquire, any financial product (including but not limited to securities);
    - 3.1.3. solicit investment in China Environment Group Limited ("CEG") from members of the public;
    - 3.1.4. receive funds deposited with, or intended for investment in, CEG;
  - 3.2. parting with possession of, or disposing of, destroying, amending, altering, or causing or procuring the destruction, amendment or alteration of, the books and records of CEG, and any documents recording money paid to or received by CEG.
- 4. Ullmann, whether personally or by his servants, agents or employees, cause to be deactivated, so that it may not be accessed by internet protocol addresses in Australia, all internet websites promoting, advertising, marketing or offering of the business of CEG, in particular but not limited to the website conducted with the domain name "http://www.chinaenvironmentgroup.com".
- 5. Pursuant to r 10.44(1) the plaintiff, Australian Securities and Investments Commission ("ASIC") be given leave to serve these orders:
  - 5.1. on Ullmann by sending these orders addressed to Ullmann by post to:

6. If the defendant does not obey the orders, he will be liable to Court proceedings and punishment for contempt and compelled to obey the orders.
